

## **Contract for Treatment**

between

in the following: Patient

**and**

in the following: St. Vincenz Hospital Brakel gGmbH  
Danziger Strasse 17, 33034 Brakel

### **§ 1 Content of Contract**

The parties to this contract agree, that the patient is admitted to the Hospital of the St. Vincenz Hospital gGmbH as an in-patient for medical treatment according to the conditions stated in the General Conditions of Contract (GCC) in the version valid at the time of admission and to the St. Vincenz Hospital gGmbH price list for its services. These are enclosed as an annexes and form part of the contract.

### **§ 2 Acceptance of Costs**

The Patient and his/her representative (legal or legal relation) undertake to pay themselves all costs arising during the Patient's stay in hospital and all services he/she has made use of. Here the Patient and any of his/her representatives who with the signing of this contract for treatment himself/herself undertake to make the payment becomes a self-payer for the St. Vincenz Hospital gGmbH. In this respect the Patient or his/her representative appears as self-pay patient with the signature on this contract and is committed to pay.

The Patient and /or his/her representative are free to claim the refund of expenses from a bearer of costs.

### **§ 3 Accompanying Person**

Should accompanying persons unexpectedly spend a night at the St. Vincenz Hospital or are catered for in the room with the Patient, then the costs caused by the accompanying person which are not directly paid by him/her are to be paid by the Patient.

### **§ 4 Non-medical Services Chargeable for Separately**

In individual cases the provision of the following non-medical services can be offered and charged for separately. The conditions for these services are included in the General Conditions of Contract (GCC) and the provisions referred to in the price list

(the relevant option is to be ticked)

- comfort single-bed room  
Accommodation in a single-bed room, with bath and catering at an additional charge of € 84,15 per day incl. VAT.
  
- comfort two-bed room  
Accommodation in a single-bed room, with bath and catering at an additional charge of € 45,48 per day incl. VAT.

## § 5 Deposit

**The Patient is obliged to pay by credit card or in cash the full amount of her/his expected treatment costs as a deposit before her/his admission to the hospital.**

**In case that the Patient will bring a cost guarantee letter from his/her insurance or any for the Patient paying institution, please note that we have to receive kind of letters in advance prior to admission.**
